THE IMPLEMENTATION AND FUNCTIONING OF FIRST IN THE MINING INDUSTRY ISO 9001:2015 INTEGRATED QUALITY MANAGEMENT SYSTEM AND THE FIRST IN THE COUNTRY ISO 14001:2015 ENVIRONMENTAL PROTECTION INTEGRATED MANAGEMENT SYSTEM AT ASSAREL-MEDET JSC CONTRIBUTED TO REACHING A SIGNIFICANT IMPROVEMENT OF THE FINANCIAL RESULTS AT THE COMPANY, SUSTAINABLE GROWTH ACHIEVEMENT OF ITS QUALITY INDICES AND MORE EFFICIENT CONTROL OF THE ENVIRONMENTAL ASPECTS.

CONTINUOUS MAINTENANCE AND IMPROVEMENT OF THE OCCUPATIONAL HEALTH AND SAFETY MANAGEMENT SYSTEM BY ENHANCING THE INDIVIDUAL COMMITMENT OF THE WORKERS AND EMPLOYEES IN THE COMPANY AND ITS SENIOR MANAGEMENT TO A SYSTEMATIC RISK ASSESSMENT AND THE SUBSEQUENT DEVELOPMENT AND IMPLEMENTATION OF PROGRAMS AIMED AT ELIMINATING AND MINIMIZING THE HIGH AND SIGNIFICANT RISK, REGULAR PERFORMANCE ASSESSMENT.
